- 1. REYNOLDS KITCHENS® COOKIE CONNOISSEUR CONTEST AND SWEEPSTAKES ("PROMOTION") SUMMARY.** Reynolds Kitchens will select a baking enthusiast to become the Cookie Connoisseur and receive \$5,000 to develop five original cookie recipes ("Contest"). Reynolds Kitchens® will also randomly award special cookie kits to 100 participants ("Sweepstakes"). Winning the Promotion Prizes (as defined below) is contingent upon Participants fulfilling all requirements set forth in these Official Rules ("Rules").
- 2. BINDING AGREEMENT.** Each person (each a "Participant" or "you") who submits an online entry during the below Promotion Period is entering into the Promotion, which is governed by these Rules. Each Participant should read these Rules before submitting the entry form to ensure Participants understand and agree. You are not eligible to receive the Prizes described in these Rules unless you agree to these Rules.
- 3. SPONSOR AND ADMINISTRATOR.** This Contest is sponsored by Reynolds Consumer Products Inc., 1900 W Field Ct, Lake Forest, IL 60045 ("Sponsor") and administered by ICF Next, Inc. 420 N 5th St. Fl. 10, Minneapolis, MN 55401 and PrizeLogic, LLC, 25200 Telegraph Road, Suite 405, Southfield, MI 48033 ("Administrators"). This Promotion is in no way sponsored, endorsed, or administered by, or associated with Facebook, Twitter or any Social Media Site utilized by the Promotion.
- 4. PROMOTION ENTRY PERIOD.** The Promotion begins at 8:00 AM Eastern Standard Time ("EST") on December 1, 2020 and ends at 11:59:59 PM EST on December 8, 2020 ("Promotion Period"). The Sponsor's clock shall be the official device for both the Entry and the Promotion. PARTICIPANTS ARE RESPONSIBLE FOR DETERMINING THE CORRESPONDING TIME ZONE IN THEIR RESPECTIVE JURISDICTION.
- 5. ELIGIBILITY – WHO MAY PARTICIPATE.** The Promotion is open only to individuals who

at the time of entry (a) are legal residents of and domiciled in the fifty (50) United States or the District of Columbia **(except for people who are legal residents of and domiciled in Maryland, North Dakota, Colorado, Michigan, Nebraska, Vermont, Tennessee, Virginia, New York, Florida, and Arizona)** and (b) who are at least the age of a majority in their state of residence (this is eighteen (18) years old in most states and nineteen (19) years old in Alabama and Nebraska). The following individuals are not eligible to participate: (i) employees of the Sponsor, any of their subsidiaries or affiliate companies, or their advertising, marketing or promotional agencies; (ii) family members (spouse, parents, siblings, children and in-laws) of any individual referred to in clause (i); (iii) persons living in the same household (whether or not related) with any person referred to in clause (i) or (ii) above; (iv) commercial enterprises and business entities; and (v) people who are residents of and domiciled in Maryland, North Dakota, Colorado, Michigan, Nebraska, Vermont, Tennessee, Virginia, New York, Florida, and Arizona. This Promotion is subject to all federal, state, and local laws and regulations and is void (a) outside the 50 United States and the District of Columbia, and (b) where prohibited by law. Any local, state, provincial or other government agency or any officials or employees thereof are not eligible to participate.

6. (“PROMOTION PRIZES”).

- **(“CONTEST PRIZE”)**: One (1) Participant (the “Contest Winner”) will be designated the Cookie Connoisseur and will receive \$5,000 USD. The approximate retail value (“ARV”) of each Prize is \$5,000 USD.
- **(“SWEEPSTAKES PRIZES”)**: One hundred (100) Participants (the “Sweepstakes Winners”) will each win a Cookie Kit comprised of: three (3) dry ingredients, one (1) recipe card, one (1) branded Reynolds Kitchens oven mitt, and one (1) custom Reynolds Kitchen box. The approximate retail value (“ARV”) of each Prize is \$200 USD. The total ARV of the Sweepstakes Prizes is up to \$3,000 USD.

7. WHAT STEPS ARE NEEDED TO ENTER AND WIN; NO PURCHASE NECESSARY.

1) **Contest Entry.** There is **one** way to enter the Contest during the Promotion Period.

- Participants must submit an original cookie recipe that uses an unexpected or wacky ingredient to careers@ReynoldsSweetGig.com
- Each submission must include age, city, state and zip code of residence (if chosen as the Contest Winner, no PO boxes mailing addressed are permitted), a photo of the cookie, the cookie recipe with bulleted list of ingredients, and explanation of why you deserve to win the Contest Prize in 250 words or less (an “Email Entry”).

2) **Sweepstakes Entry.** There are **two** ways to enter the Sweepstakes during the Promotion Period.

- All Participants that submit an Email Entry for the Contest will be automatically entered into the Sweepstakes.

- To enter the Sweepstakes without completing the steps above, Participants must send an email to careers@ReynoldsSweetGig.com including: their first and last name, age, date of birth, the city, state and zip code of their residence and mailing address (if chosen as a Sweepstakes Winner, no PO boxes mailing addressed are permitted) (“Alternative Entry”) together with Email Entry (the “Entries” and each also an “Entry”).
- 3) All Participants must review and agree to the Rules as a condition of entering the Promotion.
 - 4) All qualified Entries will be used to select the Contest Winner and the Sweepstakes Winners.
8. **ENTRY DEADLINE.** All Entries must be received on or before the end of the Promotion Period in order to be eligible to win the Prizes.
9. **SELECTION OF PROMOTION WINNERS AND NOTIFICATION**
- 1) **CONTEST WINNERS SELECTION**
 - a) To select the Contest Winner, there will be one (1) round of judging by a qualified judge selected by Sponsor in Sponsor’s sole discretion. After the Promotion Period, the Participants’ Entries are reviewed and voted on by the judge.
 - b) (“Judging Criteria”):
 - i) 1) **Passion (30%):** Participant succinctly explained why they’re cookie is the best and why they are passionate about baking/cookies.
 - ii) 2) **Taste Appeal (33%):** The description and combination of ingredients are mouthwatering and the cookie looks delicious.
 - iii) 3) **Creativity/Uniqueness (30%):** The cookie uses unique ingredients that are not usually found in cookies and the cookie has a unique theme that makes it stand out from the rest.
 - c) The judge will select the Contest Winner on or before December 16, 2020. In the event of a tie, the potential Contest Winner(s) will be the Participant whose Entry scored the highest for Creativity/Uniqueness, as determined by the judge and if such score remains tied then continuing thereafter in each category until the tie is broken.
 - d) If the Administer finds a potential Contest Winner to ineligible or finds that he or she failed to comply with these Rules, such Participant’s claim to the Contest Prize is forfeited and an alternate qualifying and eligible Participant may be selected, according to the Judging Criteria. Only three (3) alternate qualifying and eligible Participants may be contacted.
 - 2) **CONTEST WINNER NOTIFICATION**
 - a) The potential Contest Winner will be notified either via the email address or phone number included in his or her Entry within one (1) calendar day following the selection of the Contest Winner.
 - b) The potential Contest Winner will be required to provide a mailing address, and will be required to sign and return an Affidavit of Eligibility, Liability and Publicity Release (except where prohibited by law) and a properly executed IRS Form W-9 within three (3) calendar days of notification by the Administrators.

There will be one hundred (100) Sweepstakes Winners. Odds of winning depend on the total number of eligible Entries received. Entries not drawn will be carried over for any subsequent drawing. A purchase will not increase the chances of winning.
- 4) **SWEEPSTAKES WINNER NOTIFICATION**
- a) An Administrator will contact Sweepstakes Winners via the email addresses or phone numbers the Participants provided in their Entries. Participants should keep an eye on their incoming messages and calls and make sure they reply within three (3) calendar days to the message sent by the Administrator.

PERMISSIVE USE.** You grant the Sponsor, Administrators and any related affiliates or agents unlimited, worldwide, perpetual, irrevocable, and royalty-free right, license, privilege, and permission to record, copy, adapt, film, capture, use, license, transmit, broadcast, exhibit, project, publish, circulate, display, or otherwise exploit, any and all renderings of the Participant's Entry, name (including any and all nicknames, related names, and aliases), characters, biographies, artist's portrayal of characters, voice, image, likeness, visual representations, any and all attributes of the Participant's personality, and/or any and all of the Participant's acts, poses, actions, and appearances (collectively, "Name and Likeness"), and any ancillary use or derivative works on or in connection with any film, audio tape, video tape, audio-visual work, sound recordings, photograph, illustration, animation, broadcast, any derivative works or versions thereof in any media or embodiment now known or hereafter developed, throughout the world the way Sponsor or Administrators deems fit without any consideration or prior notice. Entries become the sole property of Sponsor.
- 12. ELECTRONIC COMMUNICATIONS.** By submitting the Entry, you agree to communicate for the purpose of the Promotion with the Sponsor and/or Administrators electronically.

Through your Entry submission, you (i) agree that your consent to these Rules is a binding form of your electronic signature and (ii) represent that you have Internet access and a valid email address enabling you access to information pertaining to the Promotion and to receive communications and documents electronically. Your consent is effective unless and until you withdraw it in writing to Reynolds@ICFNEXT.com
